# Specialist Skills Post Registration Development (SSPRD) funding:

SSPRD funding may be available to those meeting the eligibility criteria, to qualify you MUST:

- Be employed with an organisation who commissions NHS services.
- Work within the West Yorkshire & Harrogate District.
- Have the support and sign off from your line manager.

Each NHS area in the Yorkshire & Humber region will have a designated signatory who is to authorised to confirm that, from an organisational perspective that this level of training is required.
